Summary: Conduct of this item follows the June 12th Board approval of “Fiscal Year 2008-2009 Budget and Assessment Report” which include 1) staff’s recommendation of a district-wide “minimum benefit assessment rate” (MBAR) of \$7.25, generating \$8,000,358.74 in estimated benefit assessment revenue for FY 2008-09, and 2) a \$0.29 per parcel black fly assessment rate, generating \$90,000 within the black fly assessment zone.

The Board of Trustees regularly conducts a yearly hearing regarding adoption of its annual general benefit assessment rate. This year, the Board of Trustees intends to consider adoption of Resolution 2008-14, regarding the implementation of a district-wide “minimum benefit assessment rate” (MBAR) of \$7.25 and black fly assessment rate of \$0.29 in order to secure operational funding for fiscal year 2008-2009.

Adoption of this Resolution formalizes acceptance of the District’s minimum benefit assessment rate (MBAR) contained or modified within Resolution 2008-14 to be made effective for fiscal year 2008-2009 and placed on the County Assessor’s tax roll for collection effective July 2008. The justification and support for adopting the MBAR is contained in the District’s “Fiscal Year 2008-2009 Budget” and Assessment Report.
