9. **PUBLIC HEARING (ADOPTION OF THE FY 2011-2012 MINIMUM BENEFIT ASSESSMENT AND BLACK FLY ASSESSMENT RATES)**

Summary: Conduct of this item follows the May 31st Board approval of the Fiscal Year 2011-2012 Budget and Assessment Report which includes 1) staff's recommendation to maintain the existing district-wide "minimum benefit assessment rate" (MBAR) of \$7.25, generating \$8,058,894 in estimated benefit assessment revenue for FY 2011-2012, and 2) maintain the existing \$0.298 per parcel black fly assessment rate, generating \$91,781 within the black fly assessment zone. Staff's recommendation is to keep the assessments the same as last year.

*The Board of Trustees regularly conducts a yearly hearing regarding adoption of its annual general benefit assessment rate. This year, the Board of Trustees intends to consider adoption of **Resolution 2011-11**, regarding maintenance of a district-wide "minimum benefit assessment rate" (MBAR) of \$7.25 and black fly assessment rate of \$0.298 in order to secure operational funding for fiscal year 2011-2012.*
