**1. CALL TO ORDER**

President Levi called the meeting to order at 7:05 p.m.

Trustee Figueroa made the motion to approve the minutes. Trustee Remington seconded the motion. The motion passed unanimously.

**11. STAFF PROGRAM REPORTS: AUGUST 2008**

**11.1 Manager's Report**

Kenneth L. Bayless, General Manager

Ken Bayless provided an update on the contract situation with La Canada Flintridge, reporting that the City's staff is recommending to the City Council that the City annex into GLACVCD. The Council is expected to vote on the issue on September 15, 2008. If the annexation process is initiated, the District will continue to provide contract services in the interim.

11.2 Operations: (Staff Report A)

M. Daniel, Operations Director

Mark Daniel reported that the staff remains busy in the field. Service requests have begun to level off but the busy mosquito season will continue for a little while longer. Trustee Archuleta commented that he received some notice from residents in Pico Rivera that certain crews were treating standing water in the street gutters, and were not identifying themselves to residents. He asked if the District could notify the City when crews are controlling for mosquitoes in the area. Mark Daniel explained that the District has gutter crews that routinely treat the gutters throughout the District about every 15 days. Ken Bayless added that District vehicles are clearly marked with the District's name and logo. He added that a form letter can be sent to all member cities at the beginning of each season with a photograph of the vehicles used for mosquito control.

11.3 Scientific-Technical: (Staff Report B)

S. Kluh, Scientific-Tech Serv. Dir.

Susanne Kluh reported that additional human cases were confirmed today. 10 human cases within the District were identified over the past week. New cities to report human cases this year include Bell, Canoga Park, Carson, Granada Hills, La Mirada, and Pico Rivera. In total, there have been 30 human cases reported in the District. By this time in 2004, there had been 35 human cases reported.

Trustee Archuleta had questions regarding the difference in positive mosquito pools and birds between neighboring cities. He asked if public education was tied to these numbers. Susanne noted that Long Beach had run a successful outreach effort and that resulted in a heightened awareness among residents, leading to a high number of dead bird reports. Trustee Argumedo asked what Long Beach was doing differently in educating the public. Susanne explained that the City coordinated a door-to-door leaflet campaign. Trustee Campbell added that one of the Council members is a registered nurse and has herself, along with her staff, handed out information and spoken to residents directly about the dangers. Board members were urged to be more proactive in their own cities.

Truc Dever thanked Board members for their active involvement in public education within their own cities. She then unveiled the District's new website design, stating the live site is expected to be launched by next week.


