- All Departments this week have been working remotely on projects, trainings and strategizing from home and held regular teleconferences.
- The Operations Department staff have been contacting various fire departments, sheriff's departments, and grocery stores to ensure that field staff have access to bathrooms when out in the field. They have also been completing FEMA trainings and certifications, and developing Standard Operating Procedures manuals.

- The Scientific-Technical Services Department staff have been conducting surveillance data analysis, resistance testing, and other testing projects with mosquitoes reared from the District's mosquito colonies.
- The Community Affairs staff have been working on videos and developing new outreach materials. They created a new website landing page and a dedicated D-I-Y Resources page to send residents during this time. They are also answering email and voice message queries from the public.
- The Administrative and Fiscal Operations Departments are setting up systems to continue paying bills, and working on Emergency Operations Plans. We also have a meeting with Koff & Associates to move forward with the Class & Comp Study.
